For 55 years, Charlotte Center for Legal Advocacy and Legal Aid of North Carolina-Charlotte have been partners in justice to bridge that gap.


- They are there when a domestic violence victim needs protection.

Wendy spent three months in the hospital suffering from complications related to congestive heart failure and had her right leg amputated after developing blood clots.

"When I came home from the hospital, I was in a deep depression and needed help."

Wendy was living with her older sister who was the primary financial support for the family. She was unable to work because of her disability and her disability benefits were terminated years prior.

A Health Insurance Navigator helped Wendy enroll in Food and Nutrition Services (food stamps) and Medicaid for the Disabled, while an Advocacy Center attorney successfully appealed her benefit denial, providing her with a stable source of income.

"If it hadn't been for your staff, I think our family would have been homeless."

Advocacy Center and Legal Aid clients often face multiple civil legal issues but lack the financial resources to address them. By approaching our client's legal issues holistically, our staff ensures economic security and long-term stability.
